

MYOB Partner Awards 2023

By entering or participating in the MYOB Partner Awards 2023, you agree to be bound by these terms and conditions.

Entry requirements

 - (a) residents of Australia or New Zealand who are at least 18 years old; or
 - (b) businesses registered in Australia or New Zealand with a valid ABN or NZBN.

How to enter

3. Nominations open at 11:00am A.E.D.T / 9:00am NZDT on Wednesday, 20 March 2023. The closing date for nominations is set out on our Website, and forms part of these terms and conditions.
4. Complete and submit:
 - (a) a nomination form; and
 - (b) a written submission of up to 500 words, during the relevant nomination period in accordance with the instructions provided on our Website. You may include a short video or photos in support of your submission.
5. Any information you submit to us must be true and correct.
6. Entries must not breach the intellectual property rights of any third party, and you must obtain a licence for MYOB to use any material you submit to us.
7. You may submit an entry personally or on behalf of a colleague, your employer or another business. Multiple entries are permitted. Separate entries are required for each Award category.
8. Late entries will not be accepted. We are not liable for late, lost or misdirected entries or other communications.

Prize
